A "housing ready" community is one in which there are opportunities for development that can create a variety of options for all people in the community.

The Charlevoix County Housing Ready Program has a goal of creating attainable housing opportunities within Charlevoix County, specifically within the cities of Boyne City, Charlevoix, and East Jordan. Partners in this goal are the County of Charlevoix, Charlevoix County Community Foundation, and the Frey Foundation. The Program works with local housing networks, city, county, and township officials, employers, and other stakeholders to help Charlevoix County communities coordinate local housing initiatives and help in the development process.

PROJECT SUPPORT

CITY OF CHARLEVOIX

- Introducing Missing Middle Housing Incentives proposing specific language for Master Plan and zoning ordinance amendments.
- Worked with Yes Charlevoix on a letter of support and continued conversation on a ballot initiative to encourage housing as well as a deed restriction.

TOWNSHIPS

- Worked with FIVE Townships on potential Housing Opportunities along with funding opportunities including working with stakeholders in Beaver Island to discuss their housing options in the future.
- Facilitating housing development potential in Boyne Valley Township and Boyne Falls. Evaluating potential for utility expansion to handle additional housing and incentivize housing rehab and development.

BOYNE CITY

- Drafted new zoning language for Boyne City to create more housing-friendly options
- Working with the Boyne City Planner and manager to locate parcel options for smaller scale possible single family development

EAST JORDAN

- Evaluating priority sites and potential house for relocation in East Jordan
- Working with East Jordan ISD to expand access to building and development experiences

COUNTY

- Met with the Charlevoix Chamber and County Commissioners to discuss future of County owned property in City to become housing
- Met with County Planner To discuss County PC and Commission role in housing creation with their County owned parcels



LOWERING REGULATORY BARRIERS

- Coordinating a joint meeting between City and County of Charlevoix to work together on potential housing on former County site downtown
- Supported Marion Township by advocating for a proposed rezoning that would allow numerous manufactured homes with a proposed project
- Hosted Stakeholder meeting for future City of Charlevoix Housing plans (first zoning steps)
- Created and Launched an ADU Program to promote Accessory Dwelling Units in Charlevoix County with grant from Charlevoix County Community Foundation

- Administered custom workforce housing surveys for employees in Charlevoix County.
- Presentations at every opportunity to civic organizations (Rotary, Lion's club, Kiwanis, library boards, school boards, planning commissions, city councils).
- Attended Regional and local meetings including participated in the Regional Housing Plan representing Charlevoix County Housing Goals
- Met with stakeholders for future City of Charlevoix Housing plans (zoning amendment steps)
- Attended planning commission meetings and participated in housing opportunity discussions with three cities and County.
